OFFICIAL MINUTES

Special Meeting of the Board of Education......August 13, 2014

- I. CALL TO ORDER: The special meeting of the Board of Education was called to order by President Dama at 5:30 p.m.

He also went over some ideas for raising funds by using bricks to add permanent names built into a wall, using four different sizes with four different prices.
