1. POLICY COMMITTEE The Government Accountability Board said we needed to upgrade/revise the board policy pertaining to the duties of the Clerk of the Board.

B. ADMINISTRATIVE REPORTS

1. ROBERT CAVANAUGH

- a. NEOLA POLICY UPDATE We subscribe to this service. They keep our policies updated for us.
- NWTC CENTER OPENING Bob Johnson, Jeff Baumann and Robert Cavanaugh attended the grand opening of the NWTC Wausaukee Center. We have 7 students taking the welding class at the Wausaukee school. The students will get dual credit from NWTC and Crivitz High School.
- c. RACE TO THE TOP UPDATE Money from the federal level will go to school districts in Wisconsin. There are 11 districts that are not seeking the funds. There will be \$116,000 over a 4 year period. We will know in April if Wisconsin will get money. We can still decide not to do it at that time.

2. JEFF BAUMANN – HIGH SCHOOL PRINCIPAL

a. SEMESTER EXAMS – Of the 242 students at the high school 104 were exempt from exams either by attendance or by grades. It broke down this way: 49% Seniors, 44% Juniors, and 40% Sophomore/Freshman were exempt.

- b. ITINERARY FOR STUDENT SCHEDULING A schedule for scheduling was passed out. They will be meeting with students in the next week.
- c. NEW WEIGHT ROOM EQUIPMENT The weightroom equipment has been updated with Community Ed funds. We have replaced some equipment and added some new equipment.

- a. CHILD DEVELOPMENT DAYS Will be held February 3rd and 4th. There will be no Early Childhood, 4-K or Kindergarten those days.
- b. MOTIVATIONAL ASSEMBLY "THE TRUTH OF LIES" We will have a motivational assembly on February 5th. This will be a multi-media presentation. The assembly will be for the 6, 7, and 8th grade. The subject is the "Truth About Lies".
- c. SPELLING BEE The annual Spelling Bee will be held February 2nd at 10:00 in the gym.
